Claiming benefits such as Pension Credit, Housing Benefit and Council Tax Support is going to be even more important in the coming months, as it will mean that pensioners will continue to receive the Winter Fuel Payment. Across BCP, 383 households not claiming thier entitled Pension Credit equates to £10,578,877 in unclaimed benefits, according to data from Policy in Practice. The DWP estimates that £1.7 billion of Pension Credit went unclaimed by up to 1 million pensioner households in the financial year 2021/22. Citizens Advice BCP are encouraging people to help clients, patients, family, friends and loved ones to check their eligibility. NCS Updates for Young People

We have been successful in securing NCS funding to work with young people aged 16 - 17 (16 - 24 if the young person is a care leaver and/ or has an EHCP) on employability skills/social action projects.

This offer gives participants the opportunity to work in small groups alongside a coach to design, develop and launch a community/social action project that will have a positive impact on their community and/or your organisation. Additionally, the project will cover topics such as planning, budgeting, promotion and are designed to support a participant's personal development by improving their confidence, communication and

and their organisation.

team working skills as well as building connections and opportunities within their own community. Delivery of this project is flexible and can work around the young people

Events have included raising funds for a common room, a celebration event, a children's charity and an animal rescue. All these ideas involved planning, organising and running an event. We have enjoyed a wii bowling tournament, a film event and a cupcake sale among many others.

Participants have told us that their confidence has improved, they have enjoyed learning how to run a successful event and how to work well in a team.

We have fully funded limited places available with projects to be delivered throughout the BCP and Dorset County area. Is this something that you feel might be beneficial to the young people or groups that you work with?



NEW Funding for work with community spaces:

We are very pleased to say that DCA has been funded by Dorset Council to offer support and training for community spaces of all kinds from Village Halls to faith spaces to community centres. We want to help you to beat the challenges of rising prices, less available funding and fewer resources.

NETWORKING:

From next month we will be holding a series of tea-time, online networking meetings with speakers on the subjects that are most useful for you.

The first one is on 30th October at 5.30pm and the topic will be financial challenges faced by community spaces and how to tackle them You can reserve your space here. We will be discussing future topics - and the timings of the meetings at this first one.

TRAINING:

We are re-launching our popular FREE bite-sized live training courses. Covering issues specific to community spaces such as fundraising, policies and legal issues, you can attend live and/or see the video of the presentation afterwards. There will be loads of templates and other give-aways to help make life easier for you. The sessions will build up into a bundle of information that committee members of community spaces can access free as needed.

News from Grant Providers

Funder: Platinum Jubilee Village Hall Fund

Who can apply: Those working on a renovation or improvement project (not repair or maintenance), the work must be completed by March 2025.

How much? Grants up to £75,000, broken down as 20% of eligible project costs minimum £7,500 (project value £37,500), maximum £75,000 (project value £375,000).

Important dates: Closing in March 2025 - but applications should go in sooner rather than later.

Funder: Capital Leverage Fund (Round 5)

Who can apply: 'Not for profit' community organisations. Projects need to meet at least one of the <u>Dorset Council priorities</u> and at least one of the <u>Cultural</u> <u>Strategy</u> priorities if you are applying as a cultural organisation.

How much? Capital grant of between £1,000 and £25,000, to fund up to 20% of their total project costs. Successful applicants will be required to secure the remaining 80% of costs before any grant is made available to them.

Focusing on: Projects which will provide new and improved facilities for communities and residents in the Dorset council area. The grants can help with funding towards a diverse range of projects, including village hall or community building enhancements, renovations, adaptations, or new build projects, including car parks, play areas, multi-use games areas, theatres, community sports clubs, sports pitches, and landscaping. The council also welcome applications for capital projects that helps to address climate change themes, art, culture, and heritage projects including accredited museums.

Important dates: Applications for this round need to be completed no later than Sunday 8th September 2024.

Applications can only be accepted via the <u>online application form.</u> Find out more on our <u>website</u>.
